Invoice adjustments will be made only if the cancelation is received at least 2 weeks in advance of the enrollment date.

**General Permission Clause:** I give permission to JJ's Jam staff to escort my child \_\_\_\_\_, on the above fieldtrips off campus from the center. **All Swimming activities will be supervised by certified lifeguards provided by the field trip facility. JJ's Jam staff will also be in the water with the children assisting with supervision. Children participating in the Field Trip activities must arrive by 9:00am and plan to participate until 3:00pm. Parents will not be allowed to drop off at or pick up their child from the field trip destinations. Parents will be notified and must be willing to pick their child up from the field trip destination should health and/or behavioral issues arise that prevent their child from participating in the program. Any child presenting behavioral issues prior to a field trip departure will be excluded from the field trip and parents will be contacted for alternate care plans.**

Waiver for participants: I hereby for myself, my child, my heirs, executors and administrators, waive and release any and all rights and claims for damages I or my child may have against JJ's Jam and its representatives, successors and assigns for any and all injuries suffered by myself or my child at any activity sponsored therein. To the best of my knowledge, my child is in good health and willing to fully participate in the activities required. My signature indicates that I have read and understand information relevant to JJ's Jam Program and risks of participation in the program.

## PARTICIPATION AGREEMENT AND COMPLETE WAIVER AND RELEASE

I, \_\_\_\_\_ wish to register my minor child (hereinafter included in the words “I”, “my” and “me”) to participate in JJ’s Jam, including transportation to during and from a specific activity, if offered. In consideration of such participation, I agree as follows:

1. Risks. I know the Event could result in risks of harm, including severe personal injury, disability, death or property loss or damage (“Risks”). The Jack and Jill Childcare have no control over factors that may influence the Risks. I am experienced in the activities involved in the Event, and have no medial reason why my child’s participation is not advised.
2. Release. I voluntarily and knowingly accept full responsibility for encountering all Risks, known and unknown. On behalf of myself, my child, heirs, next of kin, successors, assigns and anyone else who might claim through me, on my behalf, or who might have person or property I may experience as a result of the Event, I acknowledge that I will not seek to have Jack and Jill Childcare, including but not limited to its directors, employees, volunteers, leaders, sponsors, event organizers, promoters, and each of their agents, representatives, successors, and assigns, and all other person associated with the Event, (“Release”) held liable in the event that any accident, injury, loss of property or any other circumstance or incident that occurs during or as a result of my child’s participation in the Event. I hereby release and agree to hold harmless Jack and Jill Childcare, its officials, agents, and employees, from any claims arising out of my child’s participation in the Event. This promise does not purport or intend to waive liability for damages, injuries, or death resulting from conduct that constitutes greater than ordinary negligence.
3. Emergency Medical Treatment. Event staff may render first aid and/or obtain medical treatment s/he deems necessary, I will be financially responsible for all cost incurred thereby, regardless of insurance coverage. Should the need arise, I do hereby authorize and consent to any x-ray, examination, anesthetic, medical, or surgical diagnosis that a physician, in the exercise of his/her best judgment, may deem advisable.
4. General. I grant Releases full permission to use images, recordings or any other record of the Event in any medium.
5. I will comply with stated and customary rules for participation. I acknowledge and agree that Event staff may terminate my child’s participation in the Event or its activities due to conduct s/he deems inappropriate. The entry fee is non- refundable and non- transferable.
6. Jurisdiction. The laws of the Jack and Jill Childcare govern validity, construction and enforceability of this Agreement, without giving effect to its conflict of laws principles, all suits, actions, claims and causes of action relating thereto shall be in the State Courts in Minnesota.

I HAVE READ THIS LEGALLY BINDING DOCUMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND AGREE TO BE BOUND BY IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT. THIS DOCUMENT MAY BE ELECTRONICALLY SIGNED. A PHOTOCOPY OR FACSIMILE WILL BE AS VALID AS AN ORIGINALLY SIGNED DOCUMENT.
